- 2. Selection will be based on qualifications, post qualification experience and performance in the interview/written/ practical test.
- 3. Claims in respect of qualifications/experience etc. should be supported by self attested copies of relevant documents. Claims without supporting documents will not be considered. Candidates shall be required to produce the originals at the time of interview.
- 4. It will be ideal to provide 2 references, especially the names of superior officer, under whom the candidate had worked in the previous organization(s).
